1. APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillor G Allman, Jane Bromley, Councillor P Clayfield, Mrs Cross, Mr Gamble, Councillor L Massey, Mrs Randell and Mr M Smith.

2. DECLARATION OF INTERESTS

There were no interests declared.

3. MINUTES

RESOLVED THAT:

The minutes of the meeting held on 16 November 2011 be approved.

4. MATTERS ARISING NOT COVERED ELSEWHERE ON THE AGENDA

Chhaya provided the group with an update on some of the issues that were raised at the last meeting and the actions that had been taken.

Shopmobility in Ashby

Chhaya advised the group that she had tried to contact Tescos with regards to the proposal, but had not had much success. The group discussed that a premises within Ashby Town Centre would be a more ideal location. The group also felt that investigating what funding would be available should be the first priority, therefore ensuring that the venture would be able to maintain the service before the location be decided.

Red & Yellow Cards

Chhaya informed the committee that she had distributed red and yellow cards to all attendees to trial at the meeting.

Litter Bins

Chhaya advised the group that she had contacted the Waste Services Manager, who had informed her the following action either had or will be taken:-

1) Refuse Collection Staff had been advised to ensure that all bins, once empty were returned to where collected from to avoid causing an obstruction and that this would form part of the Customer Care Training.

2) Officers would monitor the locations discussed around the Hugglescote area and that, if required, the frequency of litter picks would be increased and that a new bin would be sited along Ashburton Road.

The group requested that information be provided to the group as to why the Council had changed the bin collection days recently.

5. HATE CRIME AWARENESS AND THE KEEP SAFE SCHEME

Anita Chavda, Hate Incident Monitoring Officer from Leicestershire County Council, provided an update to the group on her work within the district and Leicestershire as a whole. (Copy of the presentation has been retained).

She advised the group that they were currently running their Stop and Tell week and provided the group with some case examples of incidents that had been reported and through reporting, action had been taken.

Anita and Chhaya then provided the group with an update on the Keep Safe Scheme. They asked the group to provide any suggestions of businesses that the officers could approach to discuss the scheme with.

The following suggestions were put forward: local betting shops, Costa Coffee shops, the larger supermarkets around Coalville and chemists.

Chhaya advised the group that the initial plans were to start the Keep Safe Scheme in Coalville and it was hoped to roll out the scheme around March/April 2012.

The group discussed how society had changed over the years and how much of an effect this had on bullying and hate incidents.

Councillor Richichi thanked Anita for her presentation.

6. EQUALITY AND HUMAN RIGHTS COMMISSION: HIDDEN IN PLAIN SIGHT REPORT

Chhaya advised the group that the report that had been circulated tied in with what Anita had been talking about. The report highlighted 7 core recommendations:

- There is real ownership of the issue in organisations critical to dealing with harassment. Leaders show strong personal commitment and determination to deliver change.
- Definitive data is available which spells out the scale, severity and nature of disability harassment and enables better monitoring of the performance of those responsible for dealing with it.
- The criminal justice system is more accessible and responsive to victims and disabled people and provides effective support to them.
- We have a better understanding of the motivations and circumstances of perpetrators and are able to more effectively design interventions.
- The wider community has a more positive attitude towards disabled people and better understands the nature of the problem.
- Promising approaches to preventing and responding to harassment and support systems for those who require them have been evaluated and disseminated.
- All frontline staff who may be required to recognise and respond to issues of disability-related harassment have received effective guidance and training.

7. WORK OF HANDSTAND

Deferred to the next meeting.

8. ANY OTHER BUSINESS

Chhaya advised the group that Mike Smith had requested that the following issues be looked into:-

- 1) He would like more information about access to the parks.
- 2) Would it be possible to have some disabled parking spaces provided in the small car park to the rear of the building.


Chhaya informed the group that she had contacted the relevant services and would provide an update at the next meeting.
