## ENVIRONMENTAL INFORMATION REGULATION REQUEST 1023

I write further to your email dated 02 December 2019.

I'm undertaking an environmental assessment for a plot of land north of Burton Road, Measham, Swadlincote DE12.

For the above site I am enquiring if North West Leicestershire Environmental Health Department can provide me with any information you may have on the following:

Our response:

**1. Confirm if the site is considered to be captured under Part II of the EPA, or is on the Council's contaminated land register**

Part of the site has been identified as potentially contaminated however there are no appropriate receptors onsite.

**2. Records of any contaminative uses on the site or on land adjacent to the site**

Part of the site is a landfill site and a filled canal.

**3. Records of any confirmed contamination on the site (type of contamination, severity of contamination, date of occurrence, any remediation works that have taken place)**

The site was investigated and a preliminary investigation was submitted as part of planning permission 13/00141/OUTM.
