We do not budget down to individual Green Space areas or any individual repairs and maintenaince costs, so the only figures I can provide are the routine grounds maintenance costs that get charged to the Green Spaces cost centre (General Fund Cost) as per below.

There could be some further Green Spaces routine grounds maintenance costs under Coalville Special expense areas but we don't have the information down to that level of detail.
