## FREEDOM OF INFORMATION REQUEST 1214

I write further to your email dated 01 July 2020.

Your request has been dealt with under the terms of the Freedom of Information Act 2000 (FOIA), explained on our <u>freedom of information</u> page.

## Your request:

I am requesting information relating to:

- The sale/purchase of a piece of council owned land in Tonge to the west side of 6 Peters Close, Tonge Melbourne, Derby DE73 8HH and its removal from title LT391227 to a separate title of LT513921
- 2. I request all documents relating to any enquiry about this land and its subsequent sale.
- 3. The documents include any correspondence by email or post and notes following any verbal discussions whether by telephone or in person.
- 4. All documents include, plans, maps, drawings, dimensions, the sales contract and the transfer document of the land in question.
- Any and all information regarding legal easements, reserved rights affecting the registered land and restrictive covenants affecting this title - LT513921 and particularly how these affect or relate to the directly neighbouring titles of LT502657 and LT125005
- 6. Any person(s) from the council and/or any person(s) either as individuals or from an outside company involved in and responsible for negotiating and authorising the sale.
- 7. Any and all council procedures which must be followed in deciding to sell, advertise, calculation of the selling price and selling of any council land and then of the sale of LT513921 in particular.

## Our response:

The please see the requested information attached. Personal information has been redacted under section 40 of the FOIA.

Section 40 (2) of the Freedom of Information Act 2000 provides that personal data is exempt from disclosure if one of the conditions contained in section 40 (3) is satisfied. Section 40 (3A) (a) applies where disclosure of information would contravene data protection principles.

In this case, aspects of the requested information is exempt from disclosure as it constitutes personal data and therefore its release would breach the data protection principles of article 5 of the General Data Protect Regulations (GDPR).

The supply of information in response to a freedom of information request does not confer the right to re-use the information. UK copyright law allows information supplied for the purposes of private study and non-commercial research to be used without permission. Information supplied can also be re-used for the purposes of news reporting except for in the case of photographs.
