- 4. Of (1) how many have resulted in successful prosecutions?
  - 2018 0 2019 – 1 2020 – 0
- 5. Of (1) how many times have NW leic been required to remove fly tipping waste?
  - 2018 25 2019 – 14 2020 – 41
- 6. Of (5) total number of man hours deployed to remove fly tipping? *Information not held.*
