## FREEDOM OF INFORMATION REQUEST 1309

I write further to your email dated 23 September 2020.

Your request has been dealt with under the terms of the Freedom of Information Act 2000 (FOIA), explained on our <u>freedom of information</u> page.

Your request:

Total value (in either cash or your best estimate of monetary value) of Section 106 agreements (agreements reached with property developers under section 106 of the Town and Country Planning Act) reached

Please provide this data with a year end of March 31, for each of the following years:

- April 1 2015 March 31 2016
- April 1 2016 March 31 2017
- April 1 2017 March 31 2018
- April 1 2018 March 31 2019
- April 1 2019 March 31 2020

## Our response:

This type of data is not something which we collect in this way you have requested. Therefore, in the time available we have only been able to gather information for the last two years.

- April 1 2018 March 31 2019 = £3,963,937.70
- April 1 2019 March 31 2020 = £6,254,965.76

The figures also only include those provisions included in the any obligations which refer to a monetary value. It is noted that the request asked for us to provide an estimate of monetary value for those provisions not expressed in monetary terms. We can advise that in the two years highlighted above the following number of affordable dwellings were secured.

- 2018-19 117
- 2019-20 159

These covered a wide range of types of affordable dwelling, from 100% social rented through to low cost market housing and so would have a great range of values which we unable to confidently estimate in any way.
