FREEDOM OF INFORMATION REQUEST 1349

I write further to your email dated 08 October 2020.

Your request has been dealt with under the terms of the Freedom of Information Act 2000 (FOIA), explained on our <u>freedom of information</u> page.

Your request:

In accordance with the Freedom of Information Act 2000, please would you provide me with a dataset comprising the UPRN (Unique Property Reference Number) and the BA Reference (Billing Authority Property Reference Code)* relating to all business premises which are currently identified in your local authority's area for rating purposes. As I understand the UPRN is a key component of your Local Land and Property Gazetteer.

Our response:

I can confirm that North West Leicestershire District Council holds the information you have requested. However, the information is already available on our website and is, therefore, exempt from disclosure under sections 21 and 31 of the FOIA.

The property reference data you request can be found online already as such is section 21 of the FOIA applies:

The Business Rate data sets are uploaded to our website on a quarterly basis.

Section 31 applies to the BA references requested. Section 31(1) (a) allows a public authority to withhold information if its release would, or would be likely to, prejudice the prevention or detection of crime.

To apply the exemption under section 31, we are obliged to undertake a public interest test. In this case, it is considered that the public interest in withholding the information outweighs the public interest in disclosing it and that therefore the information is exempt from release because it may be used for criminal purposes.

The supply of information in response to a freedom of information request does not confer the right to re-use the information. UK copyright law allows information supplied for the purposes of private study and non-commercial research to be used without permission. Information supplied can also be re-used for the purposes of news reporting except for in the case of photographs.
