## FREEDOM OF INFORMATION REQUEST 1386

I write further to your email dated 12 November 2020.

Your request has been dealt with under the terms of the Freedom of Information Act 2000 (FOIA), explained on our freedom of information page.

## Your request:

We request, under the Freedom of Information Act 2000, a list of all Non-Domestic rate accounts that are currently overpaid or in credit. This should include those relating to this year or any previous year on current or closed accounts.

Please could your office include the following, preferably on an emailed Excel spreadsheet, along with the date the data was extracted from your system.

- Ratepayer
- Billing Authority Reference
- Full Address of Property Concerned
- Amount of Overpayment
- Period that the Overpayment Relates to, Start and End Date Where Relevant
- The date the Overpayment was Created on the Account
- Account Closure Date if Relevant

## Our response:

I can confirm that North West Leicestershire District Council holds the information you have requested. However, the information will not be released since it is exempt from disclosure under section 31 of the Freedom of Information Act 2000.

Section 31(1) (a) allows a public authority to withhold information if its release would, or would be likely to, prejudice the prevention or detection of crime.

To apply the exemption under section 31, we are obliged to undertake a public interest test.

In this case, it is considered that the public interest in withholding the information outweighs the public interest in disclosing it and that therefore the information is exempt from release because information regarding unclaimed monies could be used for criminal purposes.

The supply of information in response to a freedom of information request does not confer the right to re-use the information. UK copyright law allows information supplied for the purposes of private

study and non-commercial research to be used without permission. Information supplied can also be re-used for the purposes of news reporting except for in the case of photographs.
