FREEDOM OF INFORMATION REQUEST 1407

I write further to your email dated 30 November 2020.

Your request has been dealt with under the terms of the Freedom of Information Act 2000 (FOIA), explained on our <u>freedom of information</u> page.

Your request:

- A list off all busines to receive the corona virus namely The Small Business Grant Fund (SBGF) and Retail Hospitality Grant Funding (RHGF) Please see spreadsheet 1407a.xlsx attached.
- 2. A list of all descretionary grants handed out by NW leicestershire council.
 - Local Authority Discretionary Grant Fund (ran from 1 June to 21 June).
 - National Restrictions Discretionary Support Grant (Opened 30 November and remains open).
 - National Restrictions Discretionary Support Grant is our own name, it is funded by the Additional Restrictions Grant.
- 3. A list of all rejected claims for both of the above. *Information not held.*
- 4. A list of all registered busines rates premises that did not apply for any of the grants above. I can confirm that North West Leicestershire District Council holds the information you have requested. However, the information will not be released since it is exempt from disclosure under section 31 of the Freedom of Information Act 2000.

Section 31(1) (a) allows a public authority to withhold information if its release would, or would be likely to, prejudice the prevention or detection of crime. To apply the exemption under section 31, we are obliged to undertake a public interest test.

In this case, it is considered that the public interest in withholding the information outweighs the public interest in disclosing it and that therefore the information is exempt from release because information regarding unclaimed monies could be used for criminal purposes.

- 5. I would like to know the company name and details of who runs the website grantapproval.co.uk the one your now using for the latest grants. *The website is ran by Ascendant Solutions Ltd, more information may be found on their website: https://www.ascendantsol.co.uk/*
- 6. I would like to see the contract between NW leicestershire and the above company. The contract with Ascendant is held by Hinckley and Bosworth Borough Council who are in partnership with our council for the purposes of Revenues and Benefits. No contract exists between Ascendant and North West Leicestershire District Council.
- I would like to know payments made from the council to the above company and any future dated payments to be made.
