## **FREEDOM OF INFORMATION REQUEST 1412**

I write further to your email dated 03 December 2020.

Your request has been dealt with under the terms of the Freedom of Information Act 2000 (FOIA), explained on our [freedom of information](#) page.

Your request:

Further to your reply received I have looked at the information supplied and can see no relevance to the information requested on the removal of the 'footpath' on Skinners Lane Whitwick (photographs originally supplied) ie *'I am writing to request details of this removal. Please include full details of the planning application and alleged consultation including the reasons for the removal, objections etc.'*

- Ref 14/00436/ADC relates to Whitwick Sports & Social Club 5-7 Market Place Whitwick - Illuminated signs
- Ref 14/00936/VCU relates to Whitwick Sports & Social Club 5-7 Market Place Whitwick - Variations of conditions of Planning Permission to allow amended design, materials, surface water scheme with installation of ATM
- Ref 09/01097/FULM relates to 5-7 Market Place Whitwick - Conversion of existing vacant scout headquarters into five apartments, demolition of working mens club etc
- Ref 12/008/52/FUL no results found
- Ref 03/00157/RET relates to Whitwick Sports & Social Club 5-7 Market Place Whitwick - Retention of three storage containers

I would again request information specifically on the removal of the 'footpath' on Skinners Lane Whitwick, including the planning application and public consultation as advised by LCC would have been carried out by NWDLC. If it is contained within the documents already provided, please advise specifically where the information can be found.

I would also draw your attention to safety concerns raised in my original email about the top of Skinners Lane regarding the bus shelter and vehicles in that area and would ask if you have passed this information to anyone within the council or have ignored this element of my email.

Our response:

The original planning permission for the Co-op in Whitwick was granted by application reference 12/00852/FUL - Demolition of existing buildings and construction of a supermarket (Use Class A1) with associated landscaping, car parking and service yard. This reference was mistyped in our initial response.

Please see the application form attached, document 1412a.pdf, and you will see from question 6 that the proposal do not require any diversion/extinguishments and/or creation of rights of ways.

We cannot comment on why Leicestershire County Council have advised differently.

Regarding the re-siting of the bus shelter, this is a matter for Leicestershire County Council to examine.

The supply of information in response to a freedom of information request does not confer the right to re-use the information. UK copyright law allows information supplied for the purposes of private study and non-commercial research to be used without permission. Information supplied can also be re-used for the purposes of news reporting except for in the case of photographs.
