FREEDOM OF INFORMATION REQUEST 1428

I write further to your email dated 11 DEcember 2020.

Your request has been dealt with under the terms of the Freedom of Information Act 2000 (FOIA), explained on our <u>freedom of information</u> page.

Your request:

I am aware that all Billing Authorities hold records of businesses that have or have not applied for Retail Relief and Small Business Rates Relief.

Please provide us with most recent information about business premises on the territory of the local authority including:

- Address of the premises,
- Property description,
- Rateable Value,
- Property Reference,
- Date Liable From,
- Effective Date,
- Name of the Company occupying the premises,
- Date, when business rates account has been incorporated,
- Ff business received or didn't receive Reliefs,
- Which reliefs,
- If premises are occupied or not since when.

Our response:

I can confirm that North West Leicestershire District Council holds the information you have requested. However, the information is exempt from disclosure under sections 21 and 31 of the FOIA.

Data regarding businesses who have claimed relief is readiliy available on our website and therefore exempt under section 21 of the FOIA. The data you request can be found here: https://www.nwleics.gov.uk/pages/business rate accounts

The Business Rate data sets are typically uploaded to our website on a quarterly basis. However, during this difficult time data sets are likely to be uploaded at a later date.

Regarding businesses that have not applied for relief or business properties that are empty, section 31(1) (a) allows a public authority to withhold information if its release would, or would be likely to, prejudice the prevention or detection of crime. To apply the exemption under section 31, we are obliged to undertake a public interest test.

In this case, it is considered that the public interest in withholding the information outweighs the public interest in disclosing it and that therefore the information is exempt from release because information regarding unclaimed monies or empty properties could be used for criminal purposes.

The supply of information in response to a freedom of information request does not confer the right to re-use the information. UK copyright law allows information supplied for the purposes of private study and non-commercial research to be used without permission. Information supplied can also be re-used for the purposes of news reporting except for in the case of photographs.
