I write further to your email dated 05 January 2021.

Your request has been dealt with under the terms of the Freedom of Information Act 2000 (FOIA), explained on our <u>freedom of information</u> page.

Your request:

1. Please state the number of Community Protection Notices (CPNs) and Community Protection Warnings (CPWs) issued by your local authority in the period November 2019-October 2020. If possible, please provide the texts of these CPNs or state their subject matter (for example, 'waste', 'neighbour nuisance', 'enforcement of social distancing').

In total, 9 CPW's and 3 CPN's were issued. A single CPW was for a neighbour dispute, another CPW refers to accumulation of waste and all the others are in connection with untidy land.

 Please state the number of Fixed Penalty Notices (FPNs) issued by your authority for the violation of Public Spaces Protection Orders (PSPOs) in the year 2020. Please give the offences for which these FPNs were issued. If your authority has a dispersal PSPO, please state the number of directions to disperse issued by your officers.
