FREEDOM OF INFORMATION REQUEST 1473

I write further to your email dated 27 January 2021.

Your request has been dealt with under the terms of the Freedom of Information Act 2000 (FOIA), explained on our <u>freedom of information</u> page.

Your request:

A list of all the empty Commercial properties within the Council area since 01/01/2010 detailing:

- 1. Full address and postcode of property
- 2. Date the property has been empty from on or after 01/01/2010
- 3. Property Description: are premises Single or Mixed Use
 - a) If property is Mixed Use: please provide the different Categories eg storage or office etc
- 4. Business Class/Category: please provide relevant class / category, eg A1, A2 etc
- 5. Rateable square footage:
 - a) If Single Use, please provide rateable square footage
 - b) If Mixed Use, please provide individual square footage if applicable
- 6. Current rateable value
 - a) If Single Use, please provide current rateable value
 - b) If Mixed Use, please provide individual current rateable values
- 7. Freeholder Company Contact Details: the Company name and full Address

Our response:

I can confirm that North West Leicestershire District Council holds the information you have requested. However, the information will not be released since it is exempt from disclosure under section 31 of the Freedom of Information Act 2000.

Section 31(1) (a) allows a public authority to withhold information if its release would, or would be likely to, prejudice the prevention or detection of crime. To apply the exemption under section 31, we are obliged to undertake a public interest test.

In this case, it is considered that the public interest in withholding the information outweighs the public interest in disclosing it and that therefore the information is exempt from release because information regarding empty properties could be used for criminal purposes.

The supply of information in response to a freedom of information request does not confer the right to re-use the information. UK copyright law allows information supplied for the purposes of private study and non-commercial research to be used without permission. Information supplied can also be re-used for the purposes of news reporting except for in the case of photographs.
