## FREEDOM OF INFORMATION REQUEST 1496

I write further to your email dated 12 February 2021.

Your request has been dealt with under the terms of the Freedom of Information Act 2000 (FOIA), explained on our freedom of information page.

## Your request:

- A list of facilities and spaces including: sport centres, leisure centres, swimming baths, gymnasiums, bowls greens, cricket greens, outdoor courts, and outdoor activity spaces, which have been transferred through a process of Community Asset Transfer and were previously owned by your local authority, during the last 25 years.
- If possible, please provide me with information concerning when the asset was transferred,
  the specific nature of the asset, the name and nature of the organisation who the asset was
  transferred to, the lease that the asset was transferred through, the length of the lease, if
  the recipients are still in ownership of the asset, and the contacts details of the recipients of
  the asset.
- Lastly, please can you confirm if transfers have occurred in the past 12 months. I understand that under the Act I am entitled to a response within 20 working days of your receipt of this request. If my request is denied in whole or in part, I ask that you justify all deletions by reference to specific exemptions of the act. I will also expect you to release all non-exempt material. I reserve the right to appeal your decision to withhold any information or to charge excessive fees. I would prefer to receive the information electronically.

## Our response:

I can confirm that this Council has not transferred any of the assets listed in the request via the community asset transfer process.

The supply of information in response to a freedom of information request does not confer the right to re-use the information. UK copyright law allows information supplied for the purposes of private study and non-commercial research to be used without permission. Information supplied can also be re-used for the purposes of news reporting except for in the case of photographs.
