## **ENVIRONMENTAL INFORMATION REGULATION REQUEST 1585**

I write further to your email dated 15 April 2021.

Your request has been dealt with under the terms of the Environmental Information Regulation 2004 (EIR), explained on our Environmental Information Regulation page.

Your request:

Can you please supply me with the noise levels recorded by the Static Noise Meter at Donington Park or any other data available for this venue on the following dates

23/06/2020 09/07/2020 16/07/2020 23/07/2020 13/08/2020 27/08/2020 03/09/2020 15/09/2020 08/10/2020

If possible can you provide the information as a LAeq value stating the time frame i.e. 1 hour or 15 minutes.

Our response:

North West Leicestershire District Council does not hold the data recorded by the Static Noise Meter at Donington Park. This is held by Donington Park.

However from the list of dates you refer to, we have our own data for 03/09/2020 and 15/09/2020:

- On the 03/09/2020 observations were carried out in Castle Donington based on the westerly wind direction at 16:45 until 17:15. Racing could be heard clearly when wind gust was low but at a reasonable level 41-45dB LAeq 15 minutes. Trees rustling nearby were louder and blocked out the racing.
- On 15/09/2020 observations were carried out towards Aston on Trent at 11:35 following a complaint being received. Building works and an angle grinder could be heard. Motorbike noise could only be heard when straining to listen.
