FEES AND CHARGES WITH EFFECT FROM 1 APRIL 2023

A sliding scale for Interments and Exclusive Rights is shown below.

Single Fees

Anyone living in the former Coalville Urban District Council at time of death.

For residents living in care homes outside the area for less than twelve months prior to date of death, evidence must be provided by the Funeral Director / applicant to qualify for single fees e.g., Council Tax bill.

Anyone living in Ellistown who pre-purchased a grave in any of the above cemeteries prior to 2002 when Ellistown became a Parish and resided in Ellistown at the time of death will be charged single interment fees.

Double Fees

Evidence of residency in the former Coalville Urban District Council must be provided by the Funeral Director / applicant between 1 year and 5 years to date of death.

Treble Fees

Evidence of residency in the former Coalville Urban District Council must be provided by the Funeral Director / applicant if more than 5 years.

***The Children's Funeral Fund**

Effective from the 23rd of July 2019, the government introduced the Children's Funeral Fund (CFF). Where applicable, fees associated with the funeral of a child up to and including the age of 17 will be claimed from the Children's Funeral Fund. This will also include the first application fee for a memorial stone on a child's grave/plot.

Please Note **The Children's Funeral Fund** requires that all claims be submitted within 6 months of the funeral date. For all requests following a funeral, i.e., for scatterings, headstones, ashes interments etc. please be aware these **MUST** be received to the North West Leicestershire in time to allow processing and for a claim to be made prior to this deadline.
