


The Local Plan affects everyone. Have your say. #LocalPlanMySay



Introduction

The North West Leicestershire Local Plan was adopted on 21 November 2017. It sets out a strategy for delivering the homes, jobs and infrastructure needed in the district between 2011 and 2031.

The council committed to start a review of the plan within three months of the date of adoption. This consultation is the first step in reviewing the plan in accordance with Government regulations (Regulation 18 of the Local Plan Regulations 2012).

Why are we reviewing the Local Plan so soon after it was adopted?

There are two main reasons why an immediate review is required:

- A shortage of employment land up to 2031 compared to what is needed (as identified in our Housing and Economic Development Needs Assessment HEDNA)
- The possible need to accommodate additional housing arising from unmet needs in Leicester city.

In addition to the above, the draft Leicester and Leicestershire Strategic Growth Plan, which has emerged since the Local Plan was prepared, represents a change which will influence the future planning of the district.

What is the Strategic Growth Plan and how does this fit in with the current consultation on the Local Plan review?

We are working together with all of the other local planning authorities in Leicestershire on a Strategic Growth Plan to guide future development across Leicestershire up to 2050.

It is the authorities' collective 'offer' to government and other partners for how (together) we can deliver the new homes, jobs, services and infrastructure which the city and county requires.

A draft Strategic Growth Plan was published for consultation in January 2018. It sets out an ambitious but realistic and achievable growth agenda with a focus upon:

- · Delivering new housing
- · Supporting the economy
- Identifying essential infrastructure
- Protecting our environment and built heritage

It is hoped that a final Strategic Growth Plan will be produced towards the end of 2018.

The review of the Local Plan will need to take account of the final Strategic Growth Plan.

The review period

The adopted Local Plan covers the period 2011-2031. Whilst we have made enough provision for housing during this time, we know that we haven't identified enough employment land compared to what is needed. A review to 2031 could, therefore, be largely limited to addressing the shortfall in employment land.

However, an end date of 2036 would allow more time between adoption and the end of the plan period, reducing the likely need for a further review earlier than the statutory requirement that plans be reviewed within five years of adoption.

This would represent a more efficient use of resources and provide certainty and stability for a longer period.

Therefore, we have concluded that the Local Plan review should go up to 2036.

Consultation question 1

Do you agree that the review should cover the period to 2036? If not why not?

The policies that will be reviewed

As the Local Plan was adopted in November 2017 most of it will not need to be reviewed – this will therefore be a 'partial' review.

The main matters which will need to be reviewed are:

- Housing, employment and shopping needs and allocations
- Infrastructure requirements as a result of new development.

In addition, the Inspector who examined the adopted Local Plan identified two other potential matters that a review could address:

- A review of the boundaries of the Area of Separation between Coalville and Whitwick
- The identification of Local Green Spaces.

We may also be a need to include new policies to address emerging national issues or gaps in existing policies including:

- Self and custom build housing
- Public health implications of new development
- · Space standards in new housing developments
- Creating local employment opportunities.

The policies that will be reviewed

It is important to note the review will also need to take in to account the following:

- The Strategic Growth Plan and any subsequent agreements that are made with the other Leicestershire authorities in respect of the distribution of new housing and employment
- The outcome of the Government's review of the National Planning Policy Framework (NPPF) which sets out the Governments planning policies with which the Local Plan has to be consistent. The Government has stated that a draft review of the NPPF will be published by Easter 2018, with the final version later in 2018.

The precise contents of the plan will be finalised after this consultation, once we have everyone's views, and to take account of the above factors when they are finalised.

Consultation question 2

Do you agree with our assessment of which policies need to be reviewed? If not, why not?

The evidence

The reviewed Local Plan will need to be supported by an appropriate evidence base.

Some aspects of the evidence base used to support the adopted Local Plan will still be up-to-date and relevant (e.g. HEDNA), but there will be a need to update some (e.g. retail capacity). In addition, some new evidence may be required.

A list of the main evidence base documents used to support the adopted Local plan is attached at Appendix A.

In addition, the following mandatory assessments will need to be undertaken:

Sustainability Appraisal

Systematically assesses the potential environmental, economic and social impacts of the Local Plan to ensure that it contributes to the objective of achieving sustainable development.

The Sustainability Appraisal will incorporate a Strategic Environmental Assessment to meet legal requirements (European Directive 2001/42/EC on the assessment of the effects of certain plans and programmes on the environment - SEA Directive);

· Habitats Regulations Assessment

Required to ensure that the Local Plan does not adversely impact upon the River Mease Special Area of Conservation (and any other similar areas designated under the Habitats Directive, but which are not within North West Leicestershire)

Viability study

Assesses the impact of the Local Plan policies and proposals from a viability perspective to ensure that the developments required to deliver the plan are viable.

Consultation question 3

- (a) Which parts of the existing evidence base do you consider:
- (i) remain relevant
- (ii) need to be updated or replaced (and why)
- (b) Are there any other evidence base studies which are required, and if so, why?

Timetable for the review

How will the Local Plan review be prepared and what is the timetable?

The plan will go through a set process of preparation, involving a number of key stages. This will include examination by an independent Planning Inspector.

Stage 1

We are at the first stage in preparing the new Local Plan. This document identifies the sort of policies that may be needed in order to guide the future development of the district.

Stage 2

In autumn 2018 we will give local people and key stakeholders the chance to comment on our emerging thoughts about what the plan should say.

Stage 3

After considering all the feedback we get from our consultation at stage 2, we will prepare what is known as the publication (pre-submission) plan.

This document will be what we consider to be ready for independent examination and is that which we would ultimately like to adopt. We will then undertake another round of consultation to allow local people and other interested parties to be able to see the Local Plan and express their views.

We expect this to happen in autumn 2019.

Stage 4 onwards

After we've had feedback on the publication version of the plan, we will submit it to the Planning Inspectorate, hopefully in late 2019 along with all the comments received at stage 3.

The Planning Inspectorate will then arrange an examination, which is likely to be held in Spring 2020. At this stage an independent Planning Inspector will assess whether the plan is 'sound' (see below).

Our aim is to have the reviewed Local plan adopted by the end of 2020.

How will the Local Plan be assessed?

To be found sound at examination a plan must be:

Positively prepared

The plan should be prepared based on a strategy which seeks to meet objectively assessed development and infrastructure requirements, including unmet requirements from neighbouring authorities where it is reasonable to do so and consistent with achieving sustainable development.

Justified

The plan should be the most appropriate strategy, when considered against the reasonable alternatives, based on proportionate evidence.

Effective

The plan should be deliverable over its period and based on effective joint working on cross-boundary strategic priorities.

Consistent with national policy

The plan should enable the delivery of sustainable development in accordance with the policies in the National Planning Policy Framework.
