



**NOTICE OF THE MAKING OF A PUBLIC PATH ORDER
TOWN AND COUNTRY PLANNING ACT 1990 – SECTION 257
THE DISTRICT OF NORTH WEST LEICESTERSHIRE
FOOTPATH P94 and P96 OFF HILL TOP FARM, STRETTON-EN-LE-FIELD
PUBLIC PATH DIVERSION ORDER 2018**

The above order was made on 12 December 2018.

The effect of the Order will be to **DIVERT** the section of public footpath P94 within the Parish of Stretton en le Field and the District of North West Leicestershire running from **Grid Reference 429571675 310577329 to Grid Reference 430342060 309907217** and create an alternative footpath instead on a line running from **Grid Reference 429571675 310577329** in a generally easterly direction for a distance of approx. 320 metres to **Grid Reference 429857722 310472281**, then in a generally north easterly direction for approx. 626 metres to **Grid Reference 430358621 310791803** then in a generally southerly direction for approx. 987 metres to **Grid Reference 430446879 310425282**, then in a generally south westerly direction for a distance of approx. 665 metres to **Grid Reference 430330031 309932915**, then in a generally south easterly direction for a distance of approx. 29 metres to **Grid Reference 430342060 309907217** as shown on the order map.

The effect of the Order will also be to **DIVERT** the section of public footpath P96 within the Parish of Stretton en le Field and the District of North West Leicestershire running from **Grid Reference 429263204 309985172 to 429904270 310540910** and create an alternative footpath instead on a line running from **429263204 309985172** in a generally northern direction for a distance of approx. 294 metres to **Grid Reference 429216466 310186949**, then in a generally north easterly direction for approx. 1018 metres to **Grid Reference 429857722 310472281** then in a generally north easterly direction for approx. 88 metres to **Grid Reference 429904270 310540910** as shown on the order map.

Any representation about or objection to the making of the Order may be sent or delivered in writing addressed to Cultural Services, North West Leicestershire District Council, Council Offices, Coalville, Leicestershire, LE67 3FJ not later than 9th January 2019. Please state the grounds on which it is made.

If no such representations or objections are duly made, or if any so made are withdrawn, North West Leicestershire District Council may itself confirm the Order as an unopposed Order. If the Order is sent to the Secretary of State for the Environment for confirmation, any representations or objections which have not been withdrawn will be sent with the Order.
