PUBLIC PATH DIVERSION ORDER

TOWN & COUNTRY PLANNING ACT 1990 SECTION 257

THE DISTRICT OF NORTH WEST LEICESTERSHIRE

FOOTPATH P94 and P96 OFF HILL TOP FARM, STRETTON-EN-LE-FIELD PUBLIC PATH DIVERSION ORDER 2018

This Order is made by North West Leicestershire District Council under Section 257 of the Town & Country Planning Act 1990, because it is satisfied that-

- a) an application for planning permission has been made under Part 3 of that Act, namely: construction of a distribution campus, planning application reference 18/01443/FULM, and
- b) if the application were granted it would be necessary to authorise the diversion of the footpaths to which this order relates in order to enable the development to be carried out".

BY THIS ORDER

- 1. The footpaths over the land shown by a bold black line on the attached map and described in Part 1 of the Schedule to this Order shall be diverted as provided below.
- There shall be created to the reasonable satisfaction of the North West Leicestershire District Council an alternative highway for use as a replacement for the said footpaths, as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map.
- 3. The diversion of the footpath shall have effect on the date on which North West Leicestershire District Council certify that the terms of Article 2 above have been complied with.
- 4. The following works shall be carried out in relation to the highway described in Part 2 of the Schedule
 - (a) Alternative Footpath P94 shall have a minimum clear width of 4.0 metres. Alternative Footpath P96 shall have a minimum clear width of 4.0 metres.
 - (b) Fingerpost to be installed at all locations where the alternative routes for the Public Footpaths meet the vehicular Highway. The Fingerposts to be provided and installed by Leicestershire County Council, funded by the developer.
 - (c) Waymark posts to a specification shown in Standard Design Drawing SDFP6 to be installed at locations agreed with Leicestershire County Council along the along the alternative routes of the Public Footpaths
 - (d) Surfacing, to a specification agreed by Leicestershire County Council, to be constructed along the alternative routes of Public Footpaths P94 and P96

- 5. The Developer is hereby required to pay the cost of carrying out the said works.
- 6. This Order may be cited as the District of North West Leicestershire (Footpath P94 and P96 Off Hill Top Farm, Stretton-en-le-Field Public Path Diversion Order 2018.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

Footpath 1

That part of public footpath P94 within the Parish of Stretton en le Field and the District of North West Leicestershire as shown by a bold black line on the plan annexed hereto which extends from the point marked D on the plan, situated at grid reference 429571675 310577329 in a generally easterly direction for a distance of approx. 316 metres to point B on the plan at Grid Reference 429857722 310472281, then in a generally south easterly direction for approx. 769 metres to point H on the plan at Grid Reference 430330031 309932915, then in a generally south easterly direction for approx. 29 metres to point E on the plan at Grid Reference 430342060 309907217.

The footpath to be diverted has no recorded width.

Footpath 2

That part of public footpath P96 within the Parish of Stretton en le Field and the District of North West Leicestershire as shown by a bold black line on the plan annexed hereto which extends from the point marked A on the plan, situated at grid reference 429263204 309985172 in a generally north easterly direction for a distance of approx. 798 metres to point B on the plan at Grid Reference 429857722 310472281, then in a generally north easterly direction for a distance of approx. 84.5 metres to point C on the plan at Grid Reference 429904270 310540910.

The footpath to be diverted has no recorded width

PART 2

DESCRIPTION OF SITE OF ALTERNATIVE HIGHWAY

Footpath 1

A footpath within the Parish of Parish of Stretton en le Field and the District of North West Leicestershire to be known as P94, as shown by broken black dashes on the plan annexed hereto, which will extend from the point marked D on the plan, situated at Grid Reference 429571675 310577329 in a generally easterly direction for a distance of approx. 320 metres to point B on the plan at Grid Reference 429857722 310472281, then in a generally north easterly direction for approx. 626 metres to point G on the plan, at Grid Reference 430358621 310791803 then in a generally southerly direction for approx. 987 metres to point I on the plan at Grid Reference 430446879 310425282, then in a generally south westerly direction for a distance of

approx. 665 metres to point H on the plan at Grid Reference 430330031 309932915, then in a generally south easterly direction to point E for a distance of approx. 29 metres on the plan at Grid Reference 430342060 309907217.

The alternative footpath will have a width of 2 metres with 1 metre clear verges either side of the footpath

Footpath 2

A footpath within the Parish of Stretton en le Field and the District of North West Leicestershire to be known as P96, as shown by broken black dashes on the plan annexed hereto, which will extend from the point marked A on the plan, situated at Grid Reference 429263204 309985172 in a generally northern direction for a distance of approx. 294 metres to point F on the plan at Grid Reference 429216466 310186949, then in a generally north easterly direction for approx. 1018 metres to point B on the plan, at Grid Reference 429857722 310472281 then in a generally north easterly direction for approx. 88 metres to point C on the plan at Grid Reference 429904270 310540910.

The alternative footpath will have a width of 2 metres with 1 metre clear verges either side of the footpath
