**Para 9.25 states: "In addition it is recognised that the Hugglescote X Roads requires improvement"** During 2015 there were 9 proposals put forward by LCC concerning Hugglescote X Road "improvements". Following intensive consultations and discussions locally and a professionally managed traffic survey to investigate volumes, destinations etc the evidence was then presented to LCC to allow them to deliberate the issue and arrive at their conclusions. On Wednesday 18<sup>th</sup> November 2015 LCC decided (Decisions Doc. 8) that " none of the proposals put forward in the consultation for improvement work at Hugglescote X Roads be pursued further"

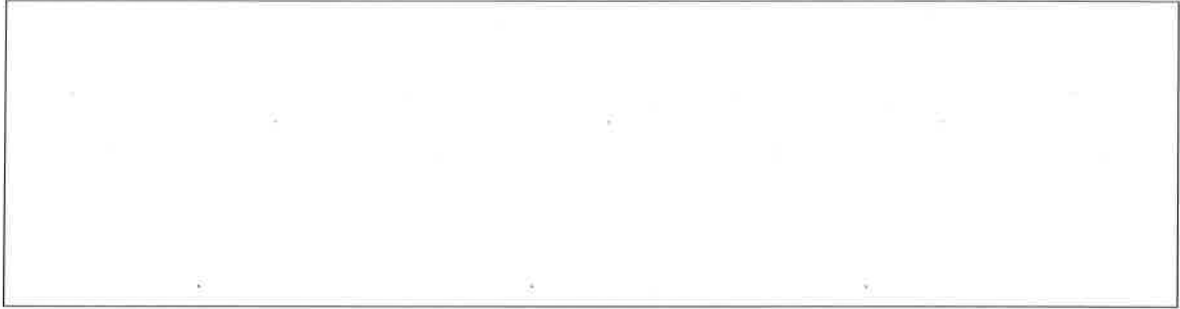
