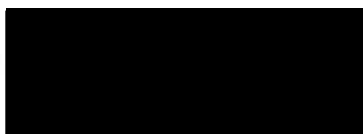

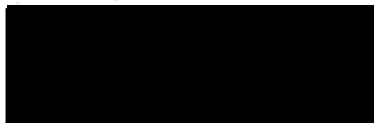

There is a lack of clarity in the document about how much of the 96 hectares for employment use will be taken up by the Strategic Rail Freight Interchange. We raised this in an earlier round of consultation and the response was that this land is in addition to the Strategic Rail Freight Interchange but the text has not be altered to make this clear.

Making provision for an additional 10,400 dwellings is excessive. A significant amount of new housing is linked to the development of the Strategic Rail Freight Interchange. The new interchange is on the border of three counties, which means the population should be evenly distributed between the three counties. The Local Plan assumes that just over 50% of the new workforce will live in North West Leicestershire. A figure of 35% would be more realistic.

An additional 10,400 dwellings are required in the District, the Local Plan states planning permission has already been granted for 11,207 dwellings. However it is expected that the development in Hugglescote will not deliver enough dwellings in the Plan period, so 1,600 dwellings needs removing from the total 11,207. Leaving 9,607 with planning permission and a shortfall of just under 800 dwellings.

In Ashby de la Zouch planning permission has already been granted for 70 dwellings off Woodcock Way and 605 dwellings at Money Hill. These developments have not been included within the planning permissions listed in the Local Plan. These permissions leave a shortfall of 125 dwellings. Ashby de la Zouch Town Council has supported the redevelopment of the Arla Dairy site which the current planning application for the site states will take up to 153 dwellings. This means 828 dwellings

can be provided in Ashby, meeting the projected shortfall. Therefore the additional 922 (1,750 less 828) dwellings proposed in the Local Plan for Ashby de la Zouch are not required. The proposed developments at Waterworks Road, Coalville and Ashby Road, Measham could be used as reserve sites.

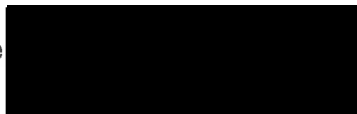

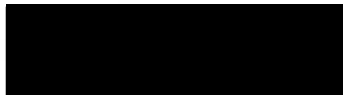
