The Draft Local Plan refers to the 2013 Department for Transport passenger forecasts. Whilst the long-term traffic forecasts for UK aviation have reduced from those prepared in 2011 as a consequence of recession, the 2013 forecasts do show that national aviation growth over the long-term is expected to remain strong.

The Airport's development and land-use proposals are set out in the Land Use Plan. The draft of the Local Plan recognises that planning consent is in place for an extension of the Airport's runway. This planning permission was granted in February 2011 and this development was formally commenced in February 2016 following the Council's confirmation that the pre-commencement planning conditions have been met. This process legally formalised the Airport's Sound Insulation Grant Scheme as required through a Unilateral Undertaking (under Section 106 of the Planning Act) made between the Airport Company and the District Council. The commencement of the runway extension also legally established a night noise envelope and a limit on the area of the Airport's night noise contour. This is based on a 55dB noise contour and is as required by the District Council in granting planning permission for the runway development. It is therefore incorrect for the Local Plan to state in Paragraph 8.45 that 'there are no restrictions on night flights' and that 'we consider the current noise climate at night to be unacceptable'. This is incorrect because the District Council's requirements for night noise control in granting consent for the runway extension are in place and are legally binding. Paragraph 8.45 should be amended to reflect this. We would be happy to discuss alternative wording for this paragraph with the District Council.

The Airport's noise policy is also included within the Sustainable Development Plan and in the Noise Action Plan (prepared under The Environmental Noise (England) Regulations 2006 (as amended)).

The noise controls that are in place at East Midlands Airport are therefore consistent with the Government's aim (Aviation Policy Framework 2013) to limit and where possible reduce the number of people that are significantly affected by aircraft noise. To achieve this there are locally agreed restrictions on night operations and the Airport regularly and publicly reports its environmental performance to the Independent Consultative Committee. The impact of aircraft noise at night has reduced considerably over recent years. For example the area of the night-time 57dB noise contour has fallen from 9.5 sq km in 2007 to 7.1 sq km in 2014. Paragraph 8.45 should be amended to recognise that night noise controls are in place.

East Midlands Airport is the largest single employment site in the District with 7,100 people employed on the site. It is also at the heart of the East Midlands Enterprise Gateway (one of Leicestershire's Growth Areas). This level of existing and future economic and employment opportunity should also be recognised within the section of the Local Plan that covers the Airport.

The Local Plan as presented in the June 2016 Consultation Draft specifically in relation to East Midlands Airport includes some elements that are considered to be unsound. These include reference to national policy in the Aviation Policy Framework, up-to-date traffic and employment data, and existing environmental measures and controls.

These issues of soundness can be addressed through amendments to the text and the policy in the Draft Local Plan and are discussed further, along with suggested text amendments, in Section 6.

Policy Ec5 and Ec6 (Aerodrome Safeguarding and Public Safety Zones) are considered to be sound and legally compliant.

Paragraphs 8.39 - 8.48 and Policy Ec4 includes the approach and policy in relation to East Midlands Airport. The Airport is recognised as a 'nationally important asset'. A reference should be made in Paragraph 8.39 to the national aviation policy that is set out in the Aviation Policy Framework (DfT 2013). The text of Paragraph 8.39 should include:

*'National aviation policy is set out in the Aviation Policy Framework (DfT 2013) that recognises the benefits of aviation and sets a primary objective to achieve long-term economic growth. As aviation is a major contributor to the economy, its growth is supported within a framework that maintains a balance between its benefits and costs, particularly climate change and noise.'*

Paragraph 8.40 should be updated to include the Airport's most recent air traffic throughput and the on-site employment numbers (2015). *2015 Passenger Throughput: 4.4 million, 2015 Cargo Throughput: 320,000 tonnes, 2015 Total On-Site Employment: 7,100*

The Airport's passenger and cargo forecasts are included within the Sustainable Development Plan (Land Use Plan). Progress will be monitored and reported. The Draft Local Plan refers to the 2013 Department for Transport passenger forecasts. Whilst the long-term traffic forecasts for UK aviation have reduced from those prepared in 2011 as a consequence of recession, the 2013 forecasts do show that national aviation growth over the long-term is expected to remain strong.

The Airport's development and land-use proposals are set out in the Land Use Plan. The draft of the Local Plan recognises that planning consent is in place for an extension of the Airport's runway. This planning permission was granted in February 2011 and this development was formally commenced in February 2016 following the Council's confirmation that the pre-commencement planning conditions have been met. This process legally formalised the Airport's Sound Insulation Grant Scheme as required through a Unilateral Undertaking (under Section 106 of the Planning Act) made between the Airport Company and the District Council. The commencement of the runway extension also legally established a night noise envelope and a limit on the area of the Airport's night noise contour. This is based on a 55dB noise contour and is as required by the District Council in granting planning permission for the runway development. It is therefore incorrect for the Local Plan to state in Paragraph 8.45 that 'there are no restrictions on night flights' and that 'we consider the current noise climate at night to be unacceptable'. This is incorrect because the District Council's requirements for night noise control in granting consent for the runway extension are in place and are legally binding. Paragraph 8.45 should be amended to reflect this. We would be happy to discuss alternative wording for this paragraph with the District Council.

The Airport's noise policy is also included within the Sustainable Development Plan and in the Noise Action Plan (prepared under The Environmental Noise (England) Regulations 2006 (as amended)).

The noise controls that are in place at East Midlands Airport are therefore consistent with the Government's aim (Aviation Policy Framework 2013) to limit and where possible reduce the number of people that are significantly affected by aircraft noise. To achieve this there are locally agreed restrictions on night operations and the Airport regularly and publicly reports its environmental performance to the Independent Consultative Committee. The impact of aircraft noise at night has reduced considerably over recent years. For example the area of the night-time 57dB noise contour has fallen from 9.5 sq km in 2007 to 7.1 sq km in 2014. Paragraph 8.45 should be amended to recognise that night noise controls are in place.

East Midlands Airport is the largest single employment site in the District with 7,100 people employed on the site. It is also at the heart of the East Midlands Enterprise Gateway (one of Leicestershire's Growth Areas). This level of existing and future economic and employment opportunity should also be recognised within the section of the Local Plan that covers the Airport.

Policy 1 should include 'a material increase in capacity or capability' This amendment is required as not all airport-related development is wholly capacity-related.
