General observations: It matters that the countryside within your District for example north of Kegworth along the A453 [east of the M1] is not eroded/urbanized ; hs2-proposal would do much environmental damage at your District hopefully finances will bin it. 'Would like Kegworth to remain a village. It's an inflexible system that it appears there wouldn't be local or District level opportunity to sensitively tweak/de-urbanize 'Roxhill' Ec1f design detail. Airport-expansion isn't the way forward. Re topography the Pegasus' Ec3 extending east would need to be very sensitive in design - H1v also - towards wider countryside aesthetics. Is there enough policy in-place to reduce light-pollution in/at the countryside ('- not entirely a 'part two' issue)? Snarrow's 'Works poor-planning near Grace Dieu Priory. [A colleague - a Hugglescote parishioner - is against H2c;] it's not altogether accurate 'Coalville Urban Area'. 'Request notification/s re the examination process. Journeying through your District there is much worth protecting. CPRE in sight of this representation.
